EVALUATION CRITERIA

Phase 1: Functionality - minimum qualifying criteria – 70 points

Phase 2: Price & B-BBEE

This phase is based on the 90/10 Preference point system in terms of the preferential procurement Policy Framework Act, with 90 reflecting price and 10 reflecting B-BBEE recognition.

SUBMISSION PROCESS
