RUSTENBURG MULTI-DIMENSIONAL INTEGRATED LOGISTICAL HUB

A multi-dimensional and integrated logistical hub is proposed to be developed at Rustenburg, which provides amongst other investment opportunities the following:

- Development of an inland Logistical Hub that interconnects all modes of transport (road, rail and airport) at the project site;
- The strengthening and expansion of road, rail and airport infrastructure to support interconnectivity is required;
- Warehousing and logistics centre will be a multimodal freight centre with multiple modes of freight transport providing logistics and distribution companies with the flexibility required to optimise logistics planning on an ongoing basis.

Medical Syringe Manufacturing

The Department of Trade and Industry’s research on the plastic sector indicates that South Africa supplies more polypropylene (PP) and polyvinylchloride than is required for local value addition. As a result, the excess raw materials are exported in a un-beneficiated state. This opportunity entails manufacturing and packaging disposable medical syringes that would consist of a PP calibrated barrel and a PP plunger with a rubber seal packaged in a high density polyethylene printed sachet.

Innovate Bio_CNG Opportunity

Innovate Bio_CNG is seeking investors and technical partner to finance, develop and operate a 3MW bio_CNG power plant in Rustenburg. This biogas power plan consists of three phases:-
 Development of feedstock supply arrangements with local farmers; construction of the power plant and sale of CNG.
 Innovate Farming Systems will provide the biogas technology and ancillary services.

Scrap Steel Recycling

The business comprises of setting up the following mentioned plant-Induction Furnace for melting of Steel scrap.
 Steel Rolling Mill - First phase – 120,000 Tonnes per annum;
 Second phase – 240,000 Tonnes per annum
 Steel Processing Yard - The steel scrap is to be sourced from

the local collectors across the nation especially from the Mines and then transported to the facility for recycling and making different products.

The end products shall be mainly sold in the local markets, out of which the mines shall be one of the large consumers of such products.

The proposed plant will directly employ 300 people in the first phase and additional 200 people in the Second phase. It could also create indirect / off-site employment for about 1800 people engaged in transport, collection, ancillary services and industries.

BLOEMHOF DAM DEVELOPMENT

The project entails the development of residential, entertainment and eco-tourism facilities around the Bloemhof Dam. Residential and entertainment facilities will be developed on the land owned by the Municipality adjacent to the dam.
