#### CRITERIA FOR APPLICATION:

- You reside in the Ngaka Modiri Molema District Municipality in North West Province
- You own one of the following businesses: Tuck-shop, Butchery Chesa Nyama, Hair salon or Bakery OR You are in a possession of land that can be used to set up a container business
- Your business is trading or has been in existence for 2 or more years
- You are a business owner between the ages of 25 and 55 years
- You have a minimum of Grade 12 or any other equivalent qualification
- You are in possession of a valid South African Identity document
- Your business is registered, with a valid tax clearance certificate and an active bank account

#### AFTER SUCCESSFUL APPLICATION THE FOLLOWING SHALL APPLY:

- Shortlisted candidates will undergo a screening process and interviews
- · Chosen candidates will undergo compulsory, intensive skills development training for the duration of 15 days
- Candidates will enter into a binding agreement with the NWDC.
