#### Phase 1: Functionality

- Completed two proposal copies i.e. One (1) Original and One (1) copy must be sealed together and **marked with the relevant proposal document number and description** thereof and must be hand delivered or couriered and dropped in the tender box at the address indicated under the above closing date and venue.
- No late submissions shall be accepted.**
- Only proposals submitted on a memory stick shall be accepted.
- All costs related to this proposal shall be carried by the service providers.
- The proposal writers will be required to make a formal presentation of their proposal to the relevant committee as and when they will be requested to do so.
- Service providers are requested to register on the Central Supplier Database <https://secure.csd.gov.za/>, which can be accessed on the National Treasury website in order to conduct business with them.
